

**Notes for laboratories for packaging and dispatch of
Infectious Substances Category A, UN 2814 specimens
and urgent transport through TOLL FAST
3 July 2015**

Laboratory requirements for TOLL transport of Infectious Substances Category A, UN 2814:

- TOLL account number
- TOLL Consignment Notes for 'Dangerous Goods' (red) for Infectious Substances Category A (in addition to the routine 'Biological Substance Category B' (blue) consignment notes) pre-printed with your account number (or blank).
- Registration on the TOLL '*Dangerous Goods - approved shippers register*'

Packaging and transport of Dangerous Goods Infectious Substances Category A

Follow procedures from CASA certification training and those given in the *NPAAC Requirements for the packaging and transport of pathology specimens and associated materials (Fourth Edition 2013)*

[Note: packaging is according to IATA Packing Instruction 620 (re-numbered from PI 602):

- **Air transport** (for compliance with *Civil Aviation Safety Regulations 1998 (CASR) Part 92 16*)
Refer to NPAAC Requirements Appendix B
 - **Triple packaging** – the rigid outer packaging must be approved to transport Infectious Substances Category A (ie must display the UN packaging specification marking)
[available from eg Bio Bottle Australia tel 02 9666 7600 or <http://www.biobottle.com.au/> rigid 'bio bottles' or A4 or A3 size 'bio pouch', includes outer fibreboard box displaying the UN packaging specification marking]
 - **Shippers Declaration for Dangerous Goods transport by air**
Require **2 copies printed in colour to show red border**
Example given in NPAAC Requirements: Figure B.2
Notes:
 - UN column: enter UN 2814
 - Proper Shipping Name: enter 'Infectious Substance Affecting Humans' and give pathogen name eg Ebola virus
 - Class or Division: enter 6.2
 - (*Packing Group not applicable*)
 - Quantity and type of packing: enter specific details
 - Packing Instruction: 620

TOLL notes: one copy of the Shippers Declaration is attached to the outside of the box in a plastic pouch, and 1 copy is given to the collecting courier – this is taken back to the TOLL depot and reviewed against a checklist prior to air transport.

- **Road transport**
 - **NPAAC Requirements Appendix J**
Gives minimum requirements for triple packaging and labelling, but for Infectious Substances Category A eg Ebola virus disease specimens, these should be packaged according to Packing Instruction 620 (as for air transport)

○ **Shipper's Declaration for transport of Dangerous Goods by Road**

Require **2 copies printed in any colour eg standard black and white**

TOLL note that there is no legal requirement to use a standard form for shipping dangerous goods by road and this can be in any style, shape or colour.

The NPAAC Requirements do not include an example of a Shipper's Road Declaration

TOLL example of a Shipper's Road Declaration (see below) provides the minimum legal requirement for information required to transport Dangerous Goods by road


Notes:

- Sender details
- Receiver details
- Consignment Note Number
- Proper Shipping Name: 'Infectious Substances Affecting Humans' (pathogen name not required)
- UN Number: UN 2814 [*note – must state 'UN' as well as the number 2814*]
- Class Number: 6.2
- (*Packing Group Number not applicable*)
- Type of Packaging used: Fibreboard box
- The number of packages in consignment: (record number as required)
- Aggregate quantity of Dangerous Good in Consignment: <500g
- Print name of person sending, signature, date

Hand both copies to the collecting courier along with the Consignment Note
