



**Exemption under the *Public Health (COVID-19 Additional Restrictions for Delta Outbreak)*
Order 2021 under the *Public Health Act 2010 (NSW)***

I, Dr Christine Selvey, authorised medical practitioner and delegate of the Minister for Health and Medical Research, under clause 25 of the *Public Health (COVID-19 Additional Restrictions for Delta Outbreak) Order 2021 (NSW) (the Order)*, hereby

- 1) Revoke the exemption signed by the Minister for Health and Medical Research on 30 June 2021 at 10.30 am and attached to this exemption; and
- 2) Grant the following exemption to the Order:
 - 1) An Exempt Person is exempt from clause 20 of the Order subject to the following conditions:
 - a. The Exempt Person only enters Greater Sydney or the Newcastle and Hunter Area for the sole purpose of receiving the COVID-19 vaccine, and
 - b. The Exempt Person travels to, and returns from, Greater Sydney or the Newcastle and Hunter Area by a private vehicle (not public transport), with no other persons other than another Exempt Person, and
 - c. The Exempt Person travels to, and returns from, Greater Sydney or the Newcastle and Hunter Area by the most practicable direct route, and
 - d. The Exempt Person does not stay overnight in Greater Sydney or the Newcastle and Hunter Area, and
 - e. The Exempt Person leaves Greater Sydney or the Newcastle and Hunter Area as soon as reasonably possible after receiving the COVID-19 vaccine, and
 - f. The Exempt Person takes all reasonably practicable steps to not enter any premises in Greater Sydney or the Newcastle and Hunter Area other than the place where the Exempt Person, or another Exempt Person, is receiving the COVID-19 vaccine.

In this instrument:

- An **Exempt Person** means a person:
 1. whose residence is in NSW and outside Greater Sydney and outside the Newcastle and Hunter Area and:
 - a) who is entering Greater Sydney or the Newcastle and Hunter Area for the sole purpose of obtaining the COVID-19 vaccine, OR
 - b) who is providing care and support to a person referred to at 1)a), AND
 2. who has NOT been:
 - a) In Greater Sydney in the previous 14 days, and
 - b) In the Newcastle and Hunter Area on or after 31 July 2021.
- **Greater Sydney** has the same meaning as under the Order.
- **Newcastle and Hunter Area** has the same meaning as the Order.

Note: as a result of this exemption, an Exempt Person is not required to comply with the requirements in the Order relating to staying at home provided that the conditions of the exemption are complied with. However, all other requirements of the Order must continue to be complied with.

Exemption under the *Public Health (COVID-19 Temporary Movement and Gathering Restrictions) Order 2021* under the *Public Health Act 2010 (NSW)*


I, Brad Hazzard, Minister for Health and Medical Research, under clause 25 of the *Public Health (COVID-19 Temporary Movement and Gathering Restrictions) Order 2021* (Order), hereby grant the following exemption to that Order:

- 1) An Exempt Person is exempt from clause 20 of the Order subject to the following conditions:
 - a. The Exempt Person only enters Greater Sydney for the sole purpose of receiving the COVID-19 vaccine, and
 - b. The Exempt Person travels to, and returns from, Greater Sydney by a private vehicle (not public transport), with no other persons other than another Exempt Person, and
 - c. The Exempt Person travels to, and returns from, Greater Sydney by the most practicable direct route, and
 - d. The Exempt Person does not stay overnight in Greater Sydney, and
 - e. The Exempt Person leaves Greater Sydney as soon as reasonably possible after receiving the COVID-19 vaccine, and
 - f. The Exempt Person takes all reasonably practicable steps to not enter any premises in Greater Sydney other than the place where the Exempt Person, or another Exempt Person, is receiving the COVID-19 vaccine.

In this instrument:

- An **Exempt Person** means any person:
 1. whose residence is in NSW and outside Greater Sydney and who is entering Greater Sydney for the sole purpose of obtaining the COVID-19 vaccine; OR
 2. who is providing care and support to a person referred to at (1).
- **Greater Sydney** has the same meaning as under the Order.

Note: as a result of this exemption, an Exempt Person is not required to comply with the requirements in the Order relating to staying at home provided that the conditions of the exemption are complied with. However, all other requirements of the Order must continue to be complied with.
