

Notice in relation to affected areas and affected workers Public Health (COVID-19 Temporary Movement and Gathering Restrictions) Order 2021 under the Public Health Act 2010 (NSW)

I Kerry Chant, Chief Health Officer, under clause 24A and clause 24B of the *Public Health* (COVID-19 Temporary Movement and Gathering Restrictions) Order 2021 (Order) hereby:

- 1) On and from the beginning of 31 July 2021, revoke the previous notice made by me on 28 July 2021 and attached to this notice.
- 2) With effect from the beginning of 31 July 20201, specify in the table below:
 - a. the following local government areas as an affected area for the purpose of Part 4A of the Order, and
 - b. the following categories of worker who live in the corresponding local government area as affected workers for the purposes of clause 24B

Affected areas	Categories of affected workers
Canterbury-Bankstown Local Government Area	All workers who live in Canterbury- Bankstown Local Government Area
Cumberland Local Government Area	Workers who live in Cumberland Local Government Area who are Health Care Workers or Aged Care Workers
City of Fairfield	Workers who live in the City of Fairfield who are Health Care Workers or Aged Care Workers

In this notice, the following definitions apply:

Health Care Worker	A person who:
TTO INC.	 provides health services within the meaning of the Health Services Act 1997 (whether or not in the public or private sector) or a registered health practitioner or a person who works for a

	registered health practitioner (each a "health services provider"), or • provides ancillary or support services to the work of a "health services provider" (as defined above) (including, for example, cleaners, cooks and security providers at hospitals)
Aged care Worker	A person who works in a residential aged care facility.
	A residential aged care facility means a facility at which the following services are provided to a person in relation to whom a residential care subsidy or flexible care subsidy is payable under the Aged Care Act 1997 of the Commonwealth— (a) accommodation, (b) personal care or nursing care.

Note: as a result of this notice:

- a person who lives in Canterbury-Bankstown Local Government Area and who
 leaves Canterbury-Bankstown Local Government Area to attend work can only enter
 premises for work outside of the Local Government Area in which they live if the
 person has been tested for COVID-19 in the previous 72 hours. The person must
 also have evidence of the test available to their employer, the occupier of premises in
 which the person works or a police officer on request.
- a person who lives in the City of Fairfield or Cumberland Local Government Area and who is an Aged Care Worker or a Health Care Worker can only enter premises for work outside of the Local Government Area in which they live if the person has been tested for COVID-19 in the previous 72 hours. The person must also have evidence of the test available to their employer, the occupier of premises in which the person works or a police officer on request.
- the occupier of the premises in which an affected worker works must not permit the worker to enter the premises unless the worker has been tested for COVID-19 in the previous 72 hours.

Note: under the Order, a person can only leave the City of Fairfield, Canterbury-Bankstown Local Government Area or Cumberland Local Government Area for work if they are an authorised worker.

I Kerry Chant, Chief Health Officer, under clause 24A and clause 24B of the *Public Health* (COVID-19 Temporary Movement and Gathering Restrictions) Order 2021 (Order) hereby:

- 1) On and from the beginning of 29 July 2021, revoke the previous notice made by me on 20 July 2021 and attached to this notice.
- 2) From the beginning of 29 July 2021 until the end of 30 July 2021, specify in the table below:
 - a. the following local government areas as an affected area for the purpose of Part 4A of the Order, and
 - b. the following categories of worker who live in the corresponding local government area as affected workers for the purposes of clause 24B

Affected areas	Categories of affected workers
Canterbury-Bankstown Local Government Area	Workers who live in Canterbury Bankstown Local Government Area who is a Health Care Worker or an Aged Care Worker
City of Fairfield	All workers who live in the City of Fairfield

In this notice, the following definitions apply:

Health Care Worker	A person who:
	 provides health services within the meaning of the Health Services Act 1997 (whether or not in the public or private sector) or a registered health practitioner or a person who works for a registered health practitioner (each a "health services provider"), or

	 provides ancillary or support services to the work of a "health services provider" (as defined above) (including, for example, cleaners, cooks and security providers at hospitals)
Aged care Worker	A person who works in a residential aged care facility.
	A residential aged care facility means a facility at which the following services are provided to a person in relation to whom a residential care subsidy or flexible care subsidy is payable under the Aged Care Act 1997 of the Commonwealth— (a) accommodation, (b) personal care or nursing care.

Note: as a result of this notice:

- a person who lives in the City of Fairfield and who leaves the City of Fairfield to attend work can only enter premises for work outside of the Local Government Area in which they live if the person has been tested for COVID-19 in the previous 72 hours. The person must also have evidence of the test available to their employer, the occupier of premises in which the person works or a police officer on request.
- a person who lives in the Canterbury-Bankstown Local Government Area and who is an Aged Care Worker or a Health Care Worker can only enter premises for work outside of the Local Government Area in which they live if the person has been tested for COVID-19 in the previous 72 hours. The person must also have evidence of the test available to their employer, the occupier of premises in which the person works or a police officer on request.
- the occupier of the premises in which an affected worker works must not permit the worker to enter the premises unless the worker has been tested for COVID-19 in the previous 72 hours.

Note: under the Order, a person can only leave the City of Fairfield or Canterbury-Bankstown Local Government Area for work if they are an authorised worker.

I Kerry Chant, Chief Health Officer, under clause 24A and clause 24B of the *Public Health* (COVID-19 Temporary Movement and Gathering Restrictions) Order 2021 (Order) hereby make the following notice with effect from the beginning of **23 July 2021**:

1) The following local government areas is specified as an affected area for the purpose of Part 4A of the Order:

Canterbury-Bankstown Local Government Area

2) Clause 24B only applies to an affected worker who lives in Canterbury-Bankstown Local Government Area and who works in one of the following areas:

Health Care	A person who:	
	 provides health services within the meaning of the Health Services Act 1997 (whether or not in the public or private sector) or a registered health practitioner or a person who works for a registered health practitioner (each a "health services provider"), or provides ancillary or support services to the work of a "health services provider" (as defined above) (including, for example, cleaners, cooks and security providers at hospitals) 	
Aged care	A person who works in a residential aged care facility. A residential aged care facility means a facility at which the following services are provided to a person in relation to whom a residential care subsidy or flexible care subsidy is payable under the Aged Care Act 1997 of the Commonwealth— (a) accommodation, (b) personal care or nursing care.

 works in Aged Care or Health Care can only enter premises for work outside of the
 Local Government Area in which they live if the person has been tested for COVID19 in the previous 72 hours. The person must also have evidence of the test
 available to their employer, the occupier of premises in which the person works or a
 police officer on request.
- the occupier of the premises in which an affected worker works must not permit the worker to enter the premises unless the worker has been tested for COVID-19 in the previous 72 hours.
