CENTRE FOR ALCOHOL AND OTHER DRUGS

Update on the implementation of the response to the SPECIAL COMMISSION OF INQUIRY INTO THE DRUG 'ICE' (ICE INQUIRY)

The Centre for Alcohol and Other Drugs (CAOD) is responsible for the implementation of the Health recommendations from the Government response to the Ice Inquiry.

In total, the Commissioner made 109 recommendations. Of those, 86 were supported by government with \$500 million over four years in funding pledged for Health and Justice to deliver targeted reforms. The final Government response provided an overview of how the \$500 million will address treatment gaps and improve health and social outcomes through a suite of cross-government initiatives, including:

- Evidence-based prevention, treatment, support and early intervention services, especially in regional and rural areas for key priority populations.
- Integrated care for people with multiple and complex needs.
- Enhancing digital capability, system navigation and virtual healthcare.
- Enhancing the AOD workforce, including Aboriginal health practitioners and peers (new jobs, traineeships, career pathway development and skills building).
- Better utilisation of data and evidence to inform system priorities, management, monitoring and evaluation.
- Expanded justice initiatives including: MERIT, Drug Court, Circle Sentencing, Justice Reinvestment, Youth Koori Court.

IMPLEMENTATION PROGRESS

EVIDENCE BASED TREATMENT AND INTEGRATED CARE: NGO SERVICE FUNDING

Progress has been made on increasing critical non-government organisation (NGO) and Aboriginal community controlled (ACCO) AOD services, including new funding for **35 NGO treatment and support services** following multiple grant rounds, including for post-custodial support services; Treatment Access Expansion and setting up new Hubs.

The investment seeks to increase the availability of AOD services with a particular focus on services designed for the priority populations identified in the inquiry. Of note,

- 86 % of new services are in regional and rural areas.
- 14% of the services will be delivered by Aboriginal community-controlled organisations, ensuring more culturally safe services for Aboriginal people.

The CAOD is proud to have worked alongside the Consumer Reference Committee (CRC) in the development and commissioning of many of these services, including having consumer representatives on the Evaluation Committees for the Hubs grants.

In addition to the funding for new services, funding is being allocated to NGOs through a **service and amenities grants** process, aiming to improve operations and amenities to better respond to current and future demand for services.

EVIDENCE BASED TREATMENT AND INTEGRATED CARE: LHD/SHN SERVICES

SCI funding has further boosted access to vital services by commissioning 19 new and 23 expanded NSW Health AOD services. Many of these new service models have a focus on integrated care and complex case management. These include Substance Use In Pregnancy and Parenting Services (SUPPS); Assertive Community Management (ACM); Hospital Consultation Liaison expansion; comorbidity models of care; increased access to withdrawal management; additional services for young people, including a new child and adolescent service at Hunter Children's Hospital; and 3 new safe assessment units.

AOD treatment services have been expanded for **people in custody**, including remand, with an enhanced model of care being implemented by Justice Health NSW drug and alcohol services; and a new adolescent specialist AOD in the Adolescent Mental Health and AOD service.

In all at least **300 FTE** have been funded across these LHD services to date, including **33** Aboriginal and **26 lived and living experience identified roles**. Recruitment has commenced and will continue through 2024.

The complete list of SCI funded services and programs (LHD, SHN, ACCO and NGO) by NSW local health district and network are appended to this document.

DIVERSION PROGRAMS

Funding enabled a major expansion of the **Magistrates Early Referral Into Treatment** (MERIT) program enhancing existing services, establishing new services as well as increasing beds in residential rehabilitation and withdrawal management.

The **NSW Drug Court** has expanded with a new court established in Dubbo in 2023, and a two-stage process to expand operations at Sydney Drug Court in 2023-24.

The Department of Communities and Justice, NSW Police, NSW Health, and Revenue NSW have agreed to commence the **Early Drug Diversion Initiative** (EDDI) on 29 February 2024. EDDI is a NSW court diversion program aimed at increasing court efficiencies and providing opportunities for people with low level drug offences to engage in health services about their drug use. St Vincent's Health Network will deliver the EDDI telephone-based drug health intervention.

WORKFORCE DEVELOPMENT

Gains have been made towards growing and developing the workforce, including the development of a much-needed **AOD workforce strategy** (due to be published early this year). This was informed by the **Inaugural NSW AOD Workforce Census** <u>REPORT</u>.

In partnership with the sector, an Employee Value Proposition (EVP) has been designed for promoting careers in the sector and strategies to retain staff.

In addition to hundreds of new roles in NGO and LHD services, there have been some targeted workforce activities including:

- 19 scholarships awarded for the Graduate Certificate in Criminology and Criminal Justice for people who work with MERIT and Drug Court.
- 60 places funded on the TAFE AOD skillset training, many already completed.
- Funding for NUAA to establish the Peer Workforce Development Program ConnectED, including skills and storytelling training, webinars, online support and a Community of Practice.
- 31 new Lyn Gardner scholarships (in 2022-23 and 2023-24) for nurses and midwives to undertake the Graduate Certificate in Drug and Alcohol nursing (priority was given to regional and rural applicants).
- AH&MRC have commenced delivery of the first 8 units of the Cert IV in AOD (9 full days) for up to 36 Aboriginal workers living in rural/remote communities.
- Funding to support a trial of a state-wide Addiction Education Program and Addiction Medicine Advanced Training Program for JMOs.
- Funding to support leadership training and development for the NGO sector.

ABORIGINAL ENGAGEMENT

An Aboriginal Strategic Collaboration Group (ASCG) has been established to help create **culturally safe programs and services** by advising and informing the CAOD's work.

The CAOD is also strengthening partnerships with AHMRC, ACDAN and the ADARRN to ensure wide consultation with Aboriginal networks on key priorities.

The work of the CAOD will be underpinned by an Aboriginal Engagement Strategy, which has been created to develop a culture that demonstrates respect for and understanding of the needs and priorities of Aboriginal people and communities in all CAOD projects and activities.

For two key initiatives, the AOD Hubs and the Post-Custodial Support Program, CAOD quarantined funding to ensure ACCOs would operate a portion of the new services. For the Hubs grant process, independent professional support was offered to ACCOs to access group and 1:1 grant writing support. As a result, 2 of the 5 Post-Custodial Support services are operated by ACCOs. For the AOD Hubs, 3 of the 12 Hubs are ACCO-led and a further 4 Hubs are partnerships that include an ACCO as a key service partner.

BETTER USE OF DATA AND EVIDENCE

Research and evaluation capacity across the state has been expanded with 6 new grants awarded to NGOs, with 5 in regional areas. Funding has also been provided to DACRIN member organisations for research capacity building in LHDs and NGOs, including training, statistical support, and equipment.

Multiple organisations have been funded to **enhance drug surveillance capability and early warning systems** in NSW. Key projects include expansion of laboratory testing capability for novel substances, improving data availability for surveillance activities, and implementing a trial of drug residue testing post overdose.

PREVENTION AND EDUCATION

The CAOD is working with the Department of Education on revising the *Principles for Drug Education in Schools*, supporting best practice, evidence based AOD prevention in schools in NSW.

Funding has been allocated for the expansion of *Preventure*, a primary and early secondary prevention program designed to delay initiation into alcohol and other drug use. The focus will be on optimising the program in regional and rural NSW.

FOCUS FOR 2024

Areas of focus for 2024 are:

- Implementation of new services and programs, including establishing a monitoring (program and system level) and evaluation framework.
- Measures to better support family, carers and friends.
- Building on the Information, Access and Support project to enable more readily
 accessible information; streamlined access to services, including consistency in
 the approach to intake and assessment; improved system navigation and
 coordination of care.
- Commissioning Hub style models in areas of remaining need.
- Increasing access to virtual care.
- Grants for Aboriginal youth focussed prevention programs and research into codesigning a new Aboriginal youth AOD prevention program.
- Targeted workforce development activities to focus on skills and capability, training content and career pathways. This includes targeted support for the growing lived/living experience and Aboriginal workforces.
- Build the evidence base and utilise data assets to support collaborative planning, proactive system responses and effective prevention and treatment responses.
- Working as a sector to manage and, where possible, mitigate the challenges arising from implementation of such a significant upscaling of capacity, including identifying strategies to assist with workforce development and/or recruitment.

Strategic opportunities:

- Strengthening service networks and partnerships across new and existing services (public, NGO and primary care) to promote visibility of AOD services, and enhanced collaboration and coordination of care.
- Working across portfolio areas to enhance system integration within and outside of health, including partnerships to better address social determinants of health.
- Alignment of related government strategic directions and priorities (Closing the Gap, Future Health, Suicide Prevention, Homelessness, Drug Summit)
- Connecting all related activities associated with quality improvement; experience and outcomes measurement; stigma and discrimination; better use of data and evidence; workforce development and best practice clinical and corporate governance (including the VBHC program of work).

- Enhancements include AOD clinicians, AOD support groups, care navigation and peer support, brokerage and dental care and piloting a mobile health outreach van.

- Delivering screening, assessment and treatment for AOD, physical and mental health issues. Withdrawal support, counselling and groups, harm reduction, case management and family and friend support.
- Including new co-occurring needs clinicians, a peer worker, mental health and AOD clinicians and an Aboriginal Health worker.

Mission Australia

Sydney LHD

- Mission Australia currently provides a number of services to support people who are homeless or at risk of homelessness within the community in the Sydney Local Health District. This service provision will soon be enhanced with the addition of AOD clinical services to support these individuals who may also have co-occurring mental health and AOD needs.
- In partnership with Sydney LHD and a range of independent, government and voluntary services across the district Mission Australia offers co-ordinated wrap around support services via case management, tenancy and housing support, AOD, mental and physical health information and support. As part of this ongoing collaboration Mission Australia will employ an AOD nurse, social worker, care navigator and peer support workers and provide access to GPs and Psychiatry.
- Support will be tailored to the needs of people accessing the service and where they feel most comfortable either via outreach, on-site at the service hub or telehealth.

AOD Hubs grants for new partnerships

Australian Community Support Organisation

Shellharbour Illawarra Shoalhaven LHD

- Specialist AOD services and wrap around care tailored to meet the needs of people aged 18 and over who are in contact with the criminal justice system in the Shellharbour region.
- In partnership with Grand Pacific Health, the service will be co-located in the Shellharbour Head to Health Hub, working closely with Justice Health NSW and other local services to refer and support clients.
- Delivering a suite of AOD treatment and support services including in-reach and comprehensive forensic AOD assessment to people in South Coast Correctional Centre, Community Corrections and Port Kembla Court.

Directions Health Services

Bega and Eden Southern NSW LHD

- A Hub delivering services tailored to specifically meet the needs of people affected by AOD in regional and rural areas, people with co-occurring AOD and mental health needs and Aboriginal and Torres Strait Islander people.
- In partnership with Katungul Aboriginal Corporation Region Health, Grand Pacific Health and Community Services and SNSWLHD.
- Services provided by the Hub will include AOD counselling and group work, peer support, mental health care, care
 navigation, community-based withdrawal, hospital in-reach. The Hub will facilitate supported access to primary
 care, Aboriginal services, services for women and children, as well as legal, education, housing and employment
 services.

Orange Aboriginal Medical Service

Orange, Bathurst and Cowra
Western NSW LHD

- A Hub delivering strengths-based and trauma-informed holistic services tailored to specifically meet the needs of Aboriginal people affected by AOD as well as the wider community.
- In partnership with Western NSW LHD and the Aboriginal Maternal and Infant Health Service.
- Services will include care navigation and AOD peer support to access AOD counselling, mental health care, dental care, positive parenting and relationship strengthening programs.
- Enhancements will allow delivery of Opioid Treatment Program as well as community-based withdrawal management.

Social Futures

Singleton

Hunter New England LHD

- A Hub tailored to meet the needs of people affected by AOD living in rural and regional areas.
- In partnership with Hunter New England LHD, Youth Express, Singleton Family support, Singleton Neighbourhood Centre, Hunter Community legal Centre, Upper Hunter Community Services and Carries Place.
- A Hub in Singleton will support local and surrounding communities including Muswellbrook, Cessnock, Kurri Kurri and Maitland. Providing care navigation, clinical AOD care, and AOD counselling with support available from Aboriginal and peer workers. The Hub will offer services specifically for pregnant women, parents with young children and young people.

St Vincent de Paul Society NSW

Armidale

Hunter New England LHD

- A Hub tailored to meet the needs of people affected by AOD living in rural and regional areas, specifically for Aboriginal people, people with co-occurring mental health issues and people in contact with the criminal justice system.
- In partnership with Armajun Aboriginal Health Service.
- Providing AOD care, withdrawal support and addiction specialists, case management, primary care, peer, carer
 and support groups. The Hub will increase treatment access options by including outreach and having community
 transport and a driver on staff.

The Salvation Army

Wagga Wagga Murrumbidgee LHD

- The Wagga Recovery Hub is tailored to meet the needs of people who are affected by AOD living in rural and regional areas, with services provided for people with co-occurring mental health issues, those who are at risk of homelessness. Aboriginal people, and people in contact with the criminal justice system.
- In partnership with St Vincent De Paul, Riverina Medical and Dental Aboriginal Organisation RivMed, Canberra Alliance for Harm Minimisation and Advocacy CAHMA, and NSW Users and AIDS Association NUAA, Stride Mental Health.
- Services include psychosocial interventions for AOD, homelessness support, mental health care, case
 management, AOD peer support groups, Aboriginal health care including an Aboriginal wellbeing worker, AOD
 Care Coordinators and peer workers. With outreach services to Ashmont, Tolland and Kooringal and online access
 also provided.
