The Far West LHD serves a population of about 30,740 (2016 Estimated Residential Population) people dispersed across the second largest geographic area (194,949 square kilometres) of all the LHDs in NSW.

Over 12% of the people we serve are Aboriginal. This population is relatively young and reflects the lower life expectancy of Aboriginal people. Of the total LHD population, 91.1 per cent are from an English speaking background.
