1. INTRODUCTION AND BACKGROUND

- 1.1. The NSW Government supports drinking water fluoridation as an effective, efficient, socially equitable and safe population approach to the prevention of tooth decay.
- 1.2. NSW Health will continue to promote the introduction of water fluoridation in non-fluoridated areas through the development of a comprehensive public health and oral health promotion strategy. The strategy will be developed in consultation with communities and stakeholders to assist in understanding and sharing responsibilities for improved oral health for all residents of New South Wales.
- 1.3. Since 2004, NSW Health has offered water utilities a 100% subsidy for approved works under the Fluoridation Capital Works Program. This guideline formulates a framework under which these grants can be considered, supported and monitored.
- 1.4. This guideline defines responsible financial management and monitoring processes. It will also assist in preparing forward estimates and ensure that payments are timely and consistent with current policies.
- 1.5. As a result of the increased awareness of the available subsidy, it has become necessary to define specific inclusions and exclusions for subsidy applications.
- 1.6. This guideline only deals with the subsidy approval process. It does not cover the initial issue of fluoridation approvals and directions, nor does it cover the process of calling for tenders. These are local procedural issues and should be dealt with at a water utility level in accordance with the NSW Code of Practice for Fluoridation of Public Water Supplies.
- 1.7. The Chief Financial Officer is the appropriately delegated officer to approve subsidy payments under the Fluoride Capital Works Program. Payment of the subsidy will be endorsed by the Director, Environmental Health Branch. Endorsement will be subject to an approval to commence operation of a fluoridation plant by the Chief Health Officer in accordance with the Code of Practice.
- 1.8. The subsidy approval will be in line with current NSW Health financial delegations.
- 1.9. NSW Health capital and infrastructure investment process requires:1.9.1 The preparation of a Business Case covering both capital and recurrent cost.1.9.2 Adherence to relevant statutory and regulatory guidelines and regulations.

2. ELIGIBILITY

- 2.1. The subsidy is available to NSW water utilities for capital and associated costs of constructing drinking water fluoridation systems.
- 2.2. Each subsidy application will be considered on its merits.
- 2.3. Subsidies may be granted for new fluoridation systems, and for complete replacement of existing fluoridation systems that do not comply with the Code of Practice, or are otherwise in need of replacement.
- 2.4. The subsidy for a system is limited to the actual incurred cost of the least capital cost option meeting the requirements of the Code of Practice.
- 2.5. NSW Health may approve more expensive options, but the subsidy will be limited to the least capital cost option. The water utility shall be responsible for the additional capital and all non-construction costs.
- 2.6. The least capital cost option is determined during approval of the system design, in conjunction with the NSW Office of Water.
- 2.7. NSW Health may provide a subsidy greater than the least capital cost option if a water utility can justify the cost based on site specific circumstances, and all reasonable steps to have been taken to minimise costs.
- 2.8. NSW Health will consider progress payments throughout the design and construction process to assist with the cash flow of water utilities.
- 2.9. NSW Health may make payments directly to contractors engaged by NSW Health to assist with implementation of water fluoridation.

3. INCLUSIONS

The subsidy covers all costs associated with constructing a fluoridation system, including:

- 3.1. Preconstruction costs for investigation, design, specification and completion of tender process including award of contract. This will be limited to 15% of the capital cost of the least cost option
- 3.2. Project management costs up to completion of successful commissioning of the completed plant. This will be limited to 10% of the capital cost of the least cost option.
- 3.3. All contract and tendering costs for the procurement of the fluoridation system.
- 3.4. Cost of purchasing laboratory fluoride testing equipment.

4. EXCLUSIONS

In general, the subsidy does not cover recurrent costs associated with operating and maintain the fluoridation system, including:

- 4.1. Repairs, maintenance and replacement of equipment.
- 4.2. Fluoridation chemicals and laboratory consumables.
- 4.3. Staffing costs for plant operation, monitoring and testing.
- 4.4. Operations Manuals separate from that provided under the plant contract.
- 4.5. Operator training.
- 4.5 Roads, reservoirs and other civil works not integral with the fluoridation plant.

5. APPLYING FOR A GRANT

- 5.1. Applications for subsidy should be made as part of the process of approval for the design and construction of a new or upgraded fluoridation system. For further information on this process, refer to the Code of Practice.
- 5.2. A water utility should indicate if it is seeking a subsidy by completing the relevant section of the Form 1. NSW Health will respond to confirm in principle support for a subsidy, or to outline the reasons why a subsidy is not supported.
- 5.3. NSW Health will inform the Fluoridation of Public Water Supplies Advisory Committee of subsidy applications and approvals.
- 5.4. NSW Office of Water will review the designs and specification for a new fluoridation system to determine the least capital cost option. NSW Office of Water will give approval to for procurement and approve the selected tender. NSW Office of Water will inform NSW Health of the total estimated project cost once a tender is awarded.
- 5.5. A water utility must inform NSW Health of any expected significant changes to the estimated project cost during the design and construction of the system.
- 5.6. Following commencement of the fluoridation system, a water utility should submit a Claim for Subsidy Payment (Section 6 of this document) to NSW Health. NSW Health will seek advice from NSW Office of Water on whether the claim is appropriate.
- 5.7. Once approved, NSW Health will request an invoice from the water utility. All invoices related to subsidy claims must be made out to:
