Issue

Schering Pty Limited following consultation with the Therapeutic Goods Administration (TGA) is recalling all batches of ULTRAVIST – 370. This extends the recall of two batches of the product (Batches 52501A, 52501B) reported to affected customers on 8 May 2006.

This recall does not include other concentrations of ULTRAVIST (- 150, - 240, - 300).

The reason for this recall is that particulate matter in conjunction with crystallisation may be present in single bottles of the product.

Please examine your current ULTRAVIST - 370 stocks immediately, isolate all bottles, and quarantine them to prevent usage. Your Schering representative will contact you in the next few days to arrange collection and replacement of the goods.

Please retain this Safety Alert in a prominent position for one month in case of stock in transit.
